- 1. Introductions —Guest presenter is Steve Early, VSCPT
- **2. Presentation:** "VT School Crisis Guide" [Steve Early] Steve presented an evaluation of the state of schools' preparedness in Vermont. By end of 2006, the VSCPT Facilitators had visited nearly 120 of Vermont's 334 schools. They presented their program to 2/3 of the school administrators in the State, visiting a little over 30% of them. Copies of the School Crisis Guide were handed out; if schools adopt the Guide, they have 4 exercises that can be done to meet their legal obligations under VSA 16 §1481. Some confusion/debate over use of term "Lock-down" vs "Secure the Building." "Secure the Building" is preferred—less threatening for the children. However, media is not likely to oblige as "lock down" is more exciting and apt to catch audience attention.
- **3.** Secretary's Report—Bob A. MOVED, and Erik E. SECONDED, to accept the Minutes of 12/10/08 as presented. *Motion passed*.

- **6. CERT**—VT Yankee Evacuation training was focus of last meeting. A.C. CERT has been designated as Windham's backup, to staff the reception center for incoming evacuees at Bellows Falls High School
- **7.** ACEPC Outreach Committee report-[Tim] First workshop was held February 12 in Vergennes for Vergennes, Panton, Addison, Waltham, and Ferrisburgh. Andrea did a great job; session was not terribly well-attended, a couple of towns lacked any participants, but those there felt they'd gotten quite a lot out of it. Remaining workshops are:
