1. Introductions

- **2.** Orwell Emergency Plan Review/Table-Top—[Tim, Bob] Tim presented a short Table-Top Power Point based on a scenario similar to that experienced during the recent late winter ice storm. The scenario included loss of power, loss of phone service, need to set up a shelter, how to go about contacting town residents, establishment of chain-of-command over the situation.
 - Bob explained how Orwell went about implementing their EOP and how the various town departments interacted during the ice storm. Sandy Korda, co-EMD, explained how they went about setting up a shelter; Tina Wood, Red Cross officer-on-duty that day, explained how the Red Cross assists in shelter set-up and management.
- **3.** Red Cross Shelter Trailer—During the break after the Plan Review, attendees were able to "tour" the Red Cross shelter-trailer that is stationed in Addison County. The trailer contains supplies needed by a shelter, e.g. cots & blankets. [A kitchen trailer can also be brought on-site by the Red Cross and includes staff and food as well as the food prep & storage areas.]
- **4. Secretary's Report**—[Robin] Charlie MOVED, Bob SECONDED, to accept the Minutes of March 26 as written. *Motion passed*.
- **5.** *Treasurer's Report*—[*Kate*] After paying bills presented for food and SIP presentation supplies, the balance at 4/30 is \$3,996.66. We have current bills from the Little Pressroom for the new batch of brochures (\$120), and one for today's food (\$98.45) totaling \$218.45. Bob MOVED, Beth SECONDED, that the report be accepted and that all currently received legal bills be paid. *Motion passed*.
- **6.** *Publicity Committee Report*: [Jessica] In Jessica's absence, Tim reported that two presentations are currently set up, one in Monkton, one in Ripton. Steve Early wants to bring the SIP presentation to the Vt. School Crisis Team meeting, May 20. The Museum Gallery Alliance is planning to put disaster management ads in the Independent—is the ACEPC interested in working with them to have an ad in the paper each Thursday? Consensus is that we are. Beth MOVED, Charlie SECONDED to have Tim pursue the idea of emergency-related ads in the Independent with the Alliance and other emergency groups.
- **7.** Accident Data Map Project: A map with locations of dangerous accident sites in the county was displayed, with markers so that anyone present having knowledge of hazardous road sections could indicate the location on the map. The map is based on VTRANS data which is not always accurate or current. The RPC hopes to be able to use more accurate data, gathered locally, to advocate for VTRANS attention to high-accident locales.

8. Other:

ACEPC Legislated Funds: We still have not received our allotted funding, Peter will look into the matter with Christine Brown to see what the hold-up is.


